RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks (the “**Release**”) is dated as of February 9, 2006. Reference is made to that certain Pledge and Security Agreement dated as of February 3, 2003 by and among Schoolhouse Furniture, Inc., a Delaware corporation (“**Company**”), Sagus Acquisition Corp., a Delaware corporation now known as Sagus International, Inc., each of the direct and indirect subsidiaries of Company, including Mohon International, Inc., a Tennessee corporation (“**Mohon**”), and BNP Paribas, as administrative agent in such capacity, (“**Secured Party**”) (as such Pledge and Security Agreement may be amended, restated, supplemented or otherwise modified from time to time). Capitalized terms not defined in this Release have meanings set forth for such terms in the Grant of Security, as defined below.

WHEREAS, pursuant to the Grant of Trademark Security Interest, dated as of February 3, 2003 (“**Grant of Security**”), Mohon pledged to Secured Party a security interest in all of its right, title or interest in or to the trademarks attached to the Grant of Security, including the trademarks listed on Schedule A (the “**Trademarks**”) and all proceeds and products of any and all of the foregoing;

WHEREAS, the Grant of Security was recorded in the United States Patent and Trademark Office on February 7, 2003 at Reel/Frame 002666/0834; and

WHEREAS, pursuant to the terms of an Asset Purchase Agreement (the “**Asset Purchase Agreement**”) dated as of February 9, 2006, among Mohon, Texwood Furniture, Ltd., a Texas limited partnership, Company, and Institutional Casework, Inc., a Tennessee corporation (“**Purchaser**”), Mohon agrees to sell, assign, transfer and convey to Purchaser, and Purchaser agrees to purchase and acquire from Mohon, all of Mohon’s right, title and interest in, to and under all of the Specified Assets (as that term is defined in the Asset Purchase Agreement) of Mohon, including the Trademarks, and Secured Party desires to release its interest in the Trademarks.


NOW THEREFORE, Secured Party hereby notifies, acknowledges to and agrees with Mohon that the security interest in the Trademarks granted by Mohon to Secured Party pursuant to the terms of the Grant of Security, is terminated and released as of the date hereof, and that Secured Party hereby releases and forever discharges all of its right, title and interest of any kind or nature granted, assigned or conveyed pursuant to the Grant of Security in and to the Trademarks.


