1. The name of the corporation is SCHAEVITZ ENGINEERING.

2. The following amendment to the Certificate of Incorporation was approved by the directors and thereafter duly adopted by the sole shareholder of the corporation on December 6, 1989:

RESOLVED, that Article FIRST of the Certificate of Incorporation of the Corporation be amended to read as follows:


FIRST: The name of the corporation is LUCAS SCHAEVITZ, INC.

3. The number of shares entitled to vote upon the amendment was 1000.

4. 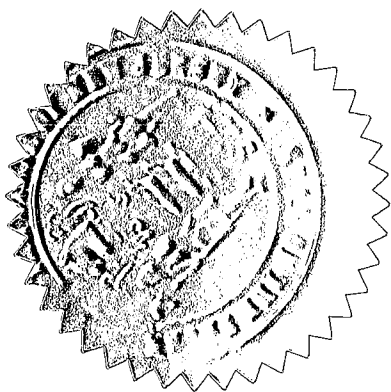
