RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release") is made as of the 12th day of January, 2006, between Gainor Medical North America, LLC, a Georgia Limited Liability Corporation ("Assignee") and Wachovia Bank, National Association, formerly known as First Union National Bank, as Agent (the "Assignor").

WHEREAS, all of the indebtedness and other obligations secured by Assignor's security interest in the Trademarks have been repaid or otherwise satisfied, and it is therefore appropriate for the Assignor to release its security interest in the Trademarks.

NOW, THEREFORE, for valuable consideration and pursuant to the terms and conditions set forth in the Agreements:

Assignor hereby terminates and releases its security interest in the Trademarks, and Assignor hereby assigns and transfers to Assignee, without any representation, warranty or recourse whatsoever, Assignor's entire right, title and interest in and to the Trademarks effective as of the date set forth above.

Assignor hereby agrees to execute such further instruments and documents and perform such further acts as Assignee may reasonably deem necessary to secure to Assignee the rights herein conveyed.
