BILL OF SALE; ASSIGNMENT AND ASSUMPTION AGREEMENT

This Bill of Sale; Assignment and Assumption Agreement is made this 1st day of January, 2005 by and between Agra Informa, Inc., a Delaware corporation ("Buyer") and Taylor & Francis Group, LLC, a Delaware limited liability company ("Seller").

BACKGROUND

1. Buyer and Seller are both indirect wholly owned subsidiaries of T&F Informa Group plc (the "Ultimate Parent Entity").

2. Prior to the date hereof, the Ultimate Parent Entity restructured its U.S. subsidiaries (the "Restructuring") as follows:

a. Taylor & Francis Group Ltd sold 100% of the capital stock of Taylor & Francis [Publishers] Inc. to Informa USA Inc. (the "Stock Sale Transaction").

b. Following the Stock Sale Transaction, Taylor & Francis [Publishers], Inc. was merged (the "Initial Merger") with and into Informa USA, Inc. causing Taylor & Francis Books, Inc. and Taylor & Francis, Inc. to be wholly owned subsidiaries of Informa USA, Inc.

c. Immediately following the Initial Merger, Taylor & Francis Books, Inc., Taylor & Francis, Inc. and CRC Press, LLC were merged with and into Seller, causing Food Chemical News ("FCN") to become a division of Seller which is currently operating in Washington, D.C

3. Effective immediately upon the consummation of the Restructuring, Seller desires to sell and assign to Buyer, and Buyer desires to purchase and assume from Seller, the FCN Assets and Assumed Liabilities (as hereinafter defined).

NOW, THEREFORE, intending to be legally bound, and in consideration of the mutual agreements contained herein, the parties hereto agree as follows:

A. Sale of Assets: Seller does hereby grant, bargain, sell, transfer, assign, convey and deliver unto Buyer, all right, title and interest in and to the Assets set forth on Exhibit A hereto (the "FCN Assets"), and Buyer does hereby purchase such FCN Assets from Seller. The purchase price for the FCN Assets shall be the book value of such FCN Assets on December 31, 2004. The consideration will be left outstanding as an inter-company balance.

B. Assignment and Acceptance. Seller hereby assigns to Buyer, and Buyer hereby assumes, the Assumed Liabilities. "Assumed Liabilities" means all debts, liabilities and obligations of any nature whatsoever, whether accrued or fixed, absolute or contingent, mature or unmatured or determined or determinable, including those arising under any law, rule or regulation, and those arising under any contract, agreement, commitment or undertaking (collectively, "Liabilities") arising from or related to the FCN Assets [arising after the Effective Time (as defined herein)]. Buyer does not, and shall not, assume, acquire, or otherwise be or become responsible or liable for any Liabilities other than the Assumed Liabilities.

C. Modification and Assignment. The agreements contained herein may not be modified or terminated orally and shall be binding upon the successors and assigns of the undersigned.

D. Effective Time. The effective time of this Agreement shall be 12:01 a.m. on January 1, 2005 (the "Effective Time").

E. Governing Law. This Agreement shall be governed by, and construed in accordance with, the laws of the State of Delaware.

F. Counterparts. This Agreement may be executed in several counterparts, each of which shall be an original and all of which together shall constitute one and the same instrument.
