Assignors, either individually or collectively, as applicable, hereby GRANT, SELL, CONVEY, TRANSFER, ASSIGN, BARGAIN, DELIVER, and RELINQUISH exclusively unto Assignee all right, title and interest in and to the Transferred Intellectual Property, including, without limitation, all Intellectual Property listed on Attachment A attached hereto, and further including, without limitation: (i) the goodwill of the Business symbolized by the names, marks, trade dress and other indicators of source included in the Transferred Intellectual Property together with all registrations, applications for registration and common law rights in the United States and any state thereof and in any country in the world; (ii) copyrights and any copyright registrations and applications included in the Transferred Intellectual Property; and (iii) confidential and proprietary information, including trade secrets, databases and other data compilations, know-how, inventions, invention disclosures, engineering designs, specifications and documentation included in the Transferred Intellectual Property. Further, Assignors, either individually or collectively, as applicable, hereby GRANT, SELL, CONVEY, TRANSFER, ASSIGN, BARGAIN, DELIVER, and RELINOUISH exclusively unto Assignee all right, title and

  - b. Institute and prosecute all suits and proceedings and take all actions that Assignee, in its sole discretion, may deem necessary or proper to collect, assert, or enforce any claim of any kind relating to any right, title, or interest assigned hereunder.
  - c. Defend and compromise any and all such actions, suits, or proceedings relating to any right, title, or interest assigned hereunder, and perform all other such acts in relation thereto as Assignee, in its sole discretion, deems advisable.
  - d. Register, maintain, renew or otherwise apply for new or continuing statutory protection for any Transferred Intellectual Property, including but without limitation, any patent, copyright, and trademark protection.
- 5. <u>Waiver</u>. Assignors hereby waive and relinquish any and all rights that they may have to any utilization of the Transferred Intellectual Property or to object to any use of the Transferred Intellectual Property by Assignee.
- 6. Controlling Agreement. It is contemplated that Assignors, either individually or collectively, may, at any time or from time to time, execute, acknowledge and deliver one or more separate instruments of assignment and conveyance relating to certain of the Transferred Intellectual Property. No such separate instrument of assignment or conveyance shall limit the scope and effect of this Assignment. In the event that any conflict or ambiguity exists as between this Assignment and any such separate instrument
