## RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Corrections Corporation of America, a Maryland corporation (formerly Prison Realty Trust, Inc., formerly Prison Realty Corporation, both Maryland corporations) (hereinafter "CCA"), is the owner of the trademark registration set forth in Schedule A, attached hereto and made a part hereof, together with the goodwill of the business symbolized by said trademark registration (the "Trademark").

WHEREAS, pursuant to that certain Notice of Grant of Security Interest in Trademarks dated as of December 31, 1998, by and among NATIONSBANK, N.A., as Administrative Agent for the Lenders referenced therein (the "Administrative Agent") and CCA, in favor of the Administrative Agent (the "Trademark Security Agreement") the Administrative Agent was and is authorized to take certain actions necessary or appropriate relating to the Trademark, including to grant and convey a release thereof.

WHEREAS, pursuant to the Trademark Security Agreement, CCA granted to the Administrative Agent a security interest in all of CCA's right, title and interest in, to and under any and all past, present and future trademarks, technology and know-how, and all licenses, royalties and other monies relating thereto, including but not limited to, the Trademark.

WHEREAS, the Trademark Security Agreement was duly recorded with the United States Patent and Trademark Office on January 25, 1999 at Reel/Frame No. 1844/0515.

WHEREAS, pursuant to that certain Assignment of Grant of Security Interest in Trademarks dated as of August 4, 1999, by and among BANK OF AMERICA, N.A. (formerly known as NATIONSBANK, N.A.) as Original Administrative Agent, and CCA (formerly known as Prison Realty Trust, Inc., formerly known as Prison Realty Corporation) and LEHMAN COMMERCIAL PAPER INC., a New York Corporation, the original Trademark Security Agreement was amended and restated in full to grant said security interest in and continuing lien upon the Trademarks to LEHMAN COMMERCIAL PAPER INC. and CCA, thereby replacing the Administrative Agent.

WHEREAS, the Assignment of Grant of Security Interest in Trademarks was duly recorded with the United States Patent and Trademark Office on August 23, 1999 at Reel/Frame No. 1949/0393.

WHEREAS, the replacement Administrative Agent acknowledges full payment, performance and satisfaction of the Secured Obligations as defined in the Trademark Security Agreement has been made, and hereby releases and discharges all right, title and interest in (if any), to and under CCA's past, present and future trademarks and reassigns any and all rights conveyed thereunder (if any), as if said agreement had never been entered into, to CCA.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged:

1. The Administrative Agent having been duly authorized to do so on behalf of itself, hereby releases and discharges the security interest granted to the Administrative Agent under the Trademark Security Agreement and re-assigns to CCA all of its right, title, and interest (if any) conveyed thereunder, in the trademarks, technology and know-how of CCA, whether currently or hereafter in existence, and all licenses, royalties and other monies relating thereto, including but not limited to each Trademark set forth in Schedule A, attached hereto and made a part hereof, together with the goodwill of the business symbolized by any of the aforesaid trademarks and the registrations of and applications for any of the aforesaid trademarks.

2. This RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release") has been executed and delivered by the Administrative Agent for the purposes described herein and for recordation, at CCA's expense, with the United States Patent and Trademark Office and, to the extent required, any other such offices in other countries of the world.


3. The Administrative Agent has a continuing obligation, at CCA's expense, to sign all agreements, documents, or otherwise, necessary to carry out this Release and the obligations herein.

4. This Release shall be binding upon and inure to the benefit of CCA's legal representatives, successors and assigns.
