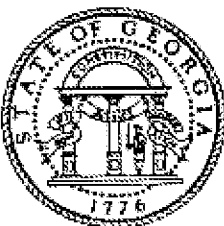

**ARTICLES OF AMENDMENT
OF
JICR ACQUISITION CORPORATION**

Pursuant to the provisions of the Georgia Business Corporation Code, the undersigned corporation hereby amends its Articles of Incorporation and for that purpose submits the following statement:

I.

The name of the corporation is JICR Acquisition Corporation.

II.

Article I of the Articles of Incorporation is hereby deleted in its entirety and the following new Article I is hereby substituted in its place:

"The name of the corporation is Vectorply Corporation."

III.

The foregoing amendment was duly adopted by the Board of Directors on December 12, 2002. In accordance with the provisions of Section 14-2-1002 of the Georgia Business Corporation Code, shareholder approval of the amendment was not required.

IV.

The corporation certifies that the request for publication of a notice of intent to file Articles of Amendment to change the name of the corporation and the payment thereof have been made as required by Section 14-2-1006.1(b) of the Georgia Business Corporation Code.
