**TRADEMARK SECURITY AGREEMENT**

**TRADEMARK SECURITY AGREEMENT**, dated as of December 30, 2005, by Paxson Communications Corporation (the "*Company*") and each of the other entities listed on the signature pages hereof or which become a party hereto (each a "*Grantor*" and collectively with the Company, collectively, the "*Grantors*") pursuant to *Section 9.10* of the Pledge and Security Agreement, dated December 30, 2005, by and among the Grantors and the Collateral Agent in favor of The Bank of New York Trust Company, NA, as collateral agent for the Secured Parties (as defined in the Security Agreement) (in such capacity, the "*Collateral Agent*").

Section 1. ***Defined Terms.*** Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement.

Section 2. ***Grant of Security Interest in Trademark Collateral.***

Each Grantor, as collateral security for the full, prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the First Priority Secured Obligations of such Grantor, hereby collaterally assigns, conveys, mortgages, pledges, hypothecates and transfers to the Collateral Agent for the benefit of the First Priority Secured Parties, and grants to the Collateral Agent for the benefit of the First Priority Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under the following Collateral of such Grantor:

- (1) all of its Trademarks and Trademark Licenses to which it is a party, including those referred to on *Schedule I* hereto;
- (2) all reissues, continuations or extensions of the foregoing;
- (3) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark License; and
- (4) all Proceeds of the foregoing, including any claim by such Grantor against third parties for past, present, future (i) infringement or dilution of any Trademark or Trademark licensed under any Trademark License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License.

Section 3. ***Security Agreement.*** The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Collateral Agent pursuant to the Security Agreement and each Grantor hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the security interest in the Trademarks made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
