## ASSIGNMENT

WHEREAS, I, DR. JUDSON E. First Avenue, Ste. 1300, Spokane, WA 99201, and other good and valuable considerations, the receipt and sufficiency whereof is hereby acknowledged, I have sold, assigned, and transferred, and by these presents do sell, assign and transfer unto said ASSIGNEE, its successors or assigns, the entire right, title and interest in and to the "VERSA-DRAPE" mark and its use throughout the United States and in all territories outside the United States, in and to any goodwill associated with the "VERSA-DRAPE" mark, in and to the above-identified "VERSA-DRAPE" APPLICATION, and in and to any future applications to be filed seeking trademark protection for the mark "VERSA-DRAPE" around the world; and I do hereby authorize and request the Commissioner of Patents and Trademarks to grant any and all United States Trademark for the above-identified "VERSA-DRAPE" APPLICATION to the ASSIGNEE as the assignee of the entire right, title and interest in and to the same, for the use of the ASSIGNEE, its successors and assigns.



AND, for the consideration aforesaid, I do hereby agree that I and my executors and legal representatives will make, execute and deliver any and all other instruments in writing including any and all further application papers, affidavits, assignments and other documents, and will communicate to said ASSIGNEE, its successors and representatives all facts known to me relating to the "VERSA-DRAPE" mark and the history thereof and will testify in all legal proceedings and generally do all things which may be necessary or desirable to more effectually secure to and vest in said ASSIGNEE, its successors or assigns the entire right, title and interest in and to the "VERSA-DRAPE" mark and its use throughout the United States and in all territories outside the United States, in and to any goodwill associated with the "VERSA-DRAPE" mark, in and to the above-identified "VERSA-DRAPE" APPLICATION, and in and to any future applications to be filed seeking trademark protection for the mark "VERSA-DRAPE" around the world hereby sold, assigned and conveyed, or intended so to be.

AND, furthermore I covenant and agree with said ASSIGNEE, its successors and assigns, that no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed has been made to others by me and that full right to convey the same as herein expressed is possessed by me.
