NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby confirm that it has assigned and hereby does assign and transfer to Assignee, its successors and assigns, absolutely and forever, its entire right, title and interest, whether statutory or at common law, in and to the

Marks and Registrations, together with the goodwill of the business symbolized thereby, including, without limitation all copyrights in the Marks and any renewals or extensions thereof and all rights of modification thereof, and all causes of action for any and all previously occurring infringements of the rights being assigned and the right to receive and retain the proceeds relating to those infringements.
