2. Seller hereby assigns the Trademark to Buyer for the payment of US\$1,000.00 by Buyer to Seller.

3. This Agreement is effective and enforceable when it has been executed by both Buyer and Seller, and Seller's acceptance has been communicated to the Buyer. Buyer shall deliver US\$12,000.00 in the form of either certified or cashier's check via Registered Mail to Seller immediately upon communication of Seller's acceptance to Buyer.
4. The Buyer may register this document in the United States Patent and Trademark Office as proof of the transfer of the Trademark to Buyer only when the Buyer has delivered US\$12,000.00 to Seller in the form of either certified or cashier's check via Registered Mail, and Canada Post has obtained signature by addressee.
5. Seller warrants the validity of United States Trademark Registration No. 2,187,762 and that she owns the Trademark. Seller represents and warrants that she is not aware of any challenge by a third party, other than EarthFresh Foods Corp., to the ownership of the Trademark, the validity of the Trademark or her right to use the Trademark, and that she is not aware of any rights belonging to a third party that might be infringed by the use of the Trademark in the United States. Seller warrants that the Agreement between her and EarthFresh Foods Corp. dated November 8, 2004, constitutes the termination of the challenge by EarthFresh Foods Corp. to United States Trademark Registration No. 2,187,762. Buyer acknowledges that he has received a copy of the EarthFresh Agreement from Seller, and both understands and agrees to comply with the conditions set forth therein.
6. Seller shall, upon the request of and at the expense of Buyer, execute all documents and do all things that in the opinion of Buyer are desirable to give effect to this assignment. Seller shall provide Buyer with all information and documents required to take over, operate and renew the domain name [www.honey-bunny.com](http://www.honey-bunny.com).
7. Seller shall not take part in any proceeding concerning the Trademark in a manner that would be contrary to the interest of Buyer, nor will Seller adopt or use any mark or name confusingly similar to, or that would dilute the distinctiveness of, the Trademark.
8. Seller shall, immediately upon executing this assignment, stop using the Trademark in any manner.
9. This Agreement is to be interpreted in accordance with the laws of the United States. The parties agree that any disputes arising under this Agreement shall be resolved in accordance with Minnesota law, except as to any matters controlled solely by U.S. Federal Law, in which case such law will govern. For the convenience of the parties, any disputes arising out of this Agreement will be resolved in the Federal Courts of the State of Minnesota, and both parties agree to submit to the personal jurisdiction of such courts and further agree that venue shall be proper in Minnesota.
