ASSIGNMENT

WHEREAS, Cenveo Corporation (formerly known as Mail-Well I Corporation d/b/a Gould Packaging), a Delaware corporation, whose principal place of business is 8310 S. CENVEO represents and warrants that it is the owner of U.S. Trademark Registration No. 2710843 for SLICKER SHIPPERS, and that it has the complete and sole right to assign the trademark SLICKER SHIPPERS.
