**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY**

**THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (this "Release") is made as of February 23, 2006 ("Effective Date") by and among: **Technical Concepts, LLC**, a Delaware limited liability company ("Grantor") and **American Capital Strategies, Ltd.** ("Grantee"), as agent for ACAS Business Loan Trust 2003-1, ACAS Business Loan Trust 2003-2 and ACAS Business Loan Trust 2004-1 (who are successors in interest to the original lenders, Liberty Partners Lenders, L.L.C., a Delaware limited liability company and American Capital Strategies, Ltd., a Delaware limited company, and the original agent, American Capital Financial Services, Inc. (the "Original Lenders").

**WHEREAS**, pursuant to the terms and conditions of that certain Subordinated Conditional Assignment of Intellectual Property and Security Agreement by and between Grantor and Grantee (as agent for the successors in interest to the Original Lenders) dated February 4, 2003 (the "IP Security Agreement") and that certain Subordinated Loan Agreement between Grantor and Grantee (as agent for the successors in interest to the Original Lenders) dated February 4, 2003, Grantor granted to Grantee a continuing security interest in and to all of Grantor's right, title and interest in and to all Intellectual Property Collateral (as defined in the IP Security Agreement) including, without limitation, all of the following: (i) all of the trademarks, and registrations of and applications to register the foregoing, and all of the trade names and assumed names owned by Grantor, together with the goodwill associated therewith (collectively, the "Trademarks"), including, without limitation, the trademark registrations and applications set forth on Schedule A attached hereto; (ii) all of Grantor's right, title and interest in and to all of the patents and patent applications owned by Grantor (collectively, the "Patents"), including, without limitation, the patents and patent applications set forth on Schedule B attached hereto; and (iii) all of the copyrights, and registrations of and applications to register the foregoing, owned by Grantor (collectively, the "Copyrights"), including, without limitation, the United States copyright registrations set forth on Schedule C attached hereto;

**WHEREAS**, the IP Security Agreement was recorded with the U.S. Patent and Trademark Office ("PTO") on April 9, 2003, at Reel 2708, Frame 0158 with respect to the Trademarks, and on April 4, 2003 at Reel 013913, Frame 0599 with respect to the Patents;

**WHEREAS**, the IP Security Agreement was recorded with the U.S. Copyright Office on April 9, 2003 at Volume 3496, Document 431; and

**WHEREAS**, Grantor has paid all of its outstanding indebtedness to Grantee (as agent for the successors in interest to the Original Lenders).

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee (as agent for the successors in interest to the Original Lenders) hereby terminates the IP Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Intellectual Property Collateral.


Grantee represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Intellectual Property Collateral; (iii) it has not recorded or otherwise evidenced its security interest with respect to (a) any trademark, or registration of an application to register any trademark, or any trade name or assumed name, (b) any patent or patent application, and (c) any copyright, or any registration of an application, other than those Trademarks, Patents and Copyrights set forth on Schedules A, B, and C (attached hereto), in any jurisdiction throughout the world.

Grantee shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
