record title to the Registration, that ASSIGNOR has full power to make this Assignment and that ASSIGNOR agrees to execute such further assignments and related documents with respect to the Mark, the Goodwill, and the Registration as ASSIGNEE shall reasonably request.

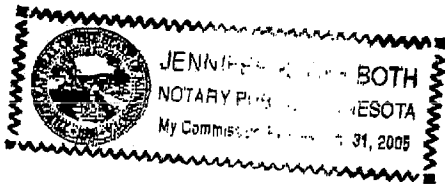
