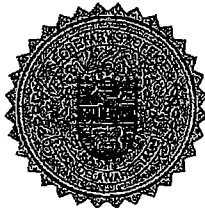

Pursuant to Title 6, Section 18-209 of the Limited Liability Company Act of the State of Delaware (the "DLLCA"), Dunkin' Donuts USA LLC, a Delaware limited liability company (the "Company"), hereby certifies to the following information relating to the merger of Dunkin' Donuts USA, Inc., a Michigan corporation (the "Old Corporation"), into the Company (the "Merger"):

FIRST: The names and states of formation and incorporation, as applicable, of the Company and the Old Corporation, which are the constituent companies in the Merger (the "Constituent Companies"), are as follows:
