**ASSIGNOR** hereby represents and warrants that (i) it owns the entire right, title and interest in and to, and have the exclusive right to use, the TRADEMARKS for the products claimed in the related registrations; (ii) to the best of the ASSIGNOR knowledge, no claims of any kind by third parties (including, without limitation, governmental authorities) relating to the TRADEMARKS have been asserted against the ASSIGNOR; and (iii) to the best of the ASSIGNOR knowledge, there are no claims by any third parties to the TRADEMARKS.




