Grocers Baking Company and Blue Bird Products, Inc. shall merge with and into Metz Baking Company and the separate corporate existence of Grocers Baking Company and Blue Bird Products, Inc. shall cease to exist. The Certificate of Incorporation and Bylaws of Metz Baking Company shall become the Charter and Bylaws of the Surviving Entity. The officers and directors of Metz Baking Company shall be the officers and directors of the Surviving Entity and they shall continue to serve in accordance with the Business Corporation Act of Iowa Law. Metz Baking Company shall assume all of the assets, liabilities and obligations of Grocers Baking Company and Blue Bird Products, Inc.

2. The merger is permitted by the state or country under whose law it is incorporated and each foreign corporation has complied with that law in effecting the merger
