
BILL OF SALE



ASSET PURCHASE AGREEMENT

THIS ASSET PURCHASE AGREEMENT (this "Agreement"), dated January 24, 2001 ("the "Closing Date") is made between WACHOVIA BANK, N.A., a national bank ("Seller"), and SUPERIOR PLANT & BULB, INC., a Georgia corporation ("Purchaser").

WHEREAS, Seller owns certain inventory and related personal property which Seller has acquired from Van Bloem, Inc., a Minnesota corporation ("Van Bloem") by foreclosure, effective this date; and;

WHEREAS, Seller wishes to sell, and Purchaser wishes to purchase, such assets, upon and subject to the terms and conditions hereinafter set forth;

NOW THEREFORE, in consideration of the mutual agreements and covenants hereinafter set forth, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

ARTICLE 1

SALE AND PURCHASE

SECTION 1.1 Assets To Be Sold and Purchased.

(a) Subject to the other terms and conditions hereof, on the Closing Date, Seller shall sell, assign, transfer, convey and deliver to Purchaser, and Purchaser shall purchase from Seller, the following assets (collectively, the "Assets"):

- (i) all that inventory set forth and described on Exhibit "A" annexed hereto (the "Category 1 Assets");
- (ii) all of the intangible assets set forth and described on Exhibit "B" annexed hereto, together with all that equipment set forth and described on Exhibit "C" annexed hereto (collectively, the "Category 2 Assets");
- (iii) the additional equipment set forth and described on Exhibit "D" annexed hereto (collectively, "Category 3 Assets");
- (iv) the additional inventory presently located in the Van Bloem Greenhouse (the "Greenhouse") set forth and described on Exhibit "E" annexed hereto (the "Category 4 Assets"); and
- (v) the additional "in-ground" inventory set forth and described on Exhibit "F" annexed hereto (the "Category 5 Assets").
