## NOTARIAL STATEMENT

I, Christiaan Maria Stokkermans, civil law notary in Amsterdam, the Netherlands, declare:

- (a) Greif International Holding B.V. (the **Company**) is a private limited liability company (*besloten vennootschap met beperkte aansprakelijkheid*), duly incorporated and validly existing under the laws of the Netherlands, having its official seat in Amstelveen, the Netherlands, and its office address at Bergseweg 6, 3633 AK Vreeland, the Netherlands.
- (b) The Company was incorporated on 25 January 1947.
- (c) The Company was transformed from a public company (*naamloze vennootschap*) named Koninklijke Emballage Industrie Van Leer N.V., into a private limited liability company (*besloten vennootschap met beperkte aansprakelijkheid*) named Koninklijke Emballage Industrie Van Leer B.V., on 2 July 2001 and in connection with this transformation of the Company's legal form, its Articles of Association were amended. The transformation and the amendment of the Articles of Association were effectuated by deed, executed on 2 July 2001 before Frank Evert Roos, civil law notary in Rotterdam, the Netherlands. A ministerial Statement of No Objections, required for the said amendment of the Articles of Association, was granted on 2 July 2001, under number BV 59082.
- (d) The Company changed its name from Koninklijke Emballage Industrie Van Leer B.V. (in dealings abroad using the name Royal Packaging Industries Van Leer B.V.) to Greif International Holding B.V. by deed of amendment of the Articles of Association, executed on 19 March 2003 before me, civil law notary. A ministerial Statement of No Objections, required for the said amendment of the Articles of Association, was granted on 13 March 2003, under number BV 59082.
- (e) The Company is currently registered in the Commercial Register under number 33065401.
