**TERMINATION AND RELEASE OF SECURITY INTEREST**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST (hereinafter referred to as the "Release") is made as of the 28 day of February, 2006 by CHATHAM CAPITAL MANAGEMENT II, LLC, a Delaware limited liability company, ("Agent") having offices at 100 Galleria Parkway, Suite 270, Atlanta, Georgia 30339, in its capacity as agent for and on behalf CHATHAM INVESTMENT FUND II, LLC and FORTRESS CREDIT OPPORTUNITIES I LP (collectively "Purchasers") in favor of FOUR SEASONS HEALTHCARE, INC., HEALTHFIELD, INC., HEALTHFIELD HOME HEALTH, INC., HEALTHFIELD CARE AT HOME, INC., HEALTHFIELD HOSPICE SERVICES, INC., MID-SOUTH HOME HEALTH AGENCY, INC., MID-SOUTH HOME CARE SERVICES, INC., TC/NC ACQUISITION COMPANY and TC/SC ACQUISITION COMPANY, and their respective successors and assigns (collectively "Releasees").

RECITAL

Pursuant to a Trademark Security Agreement dated September 25, 2003, and recorded with the United States Patent and Trademark Office on October 2, 2003 at Reel 002725 and Frame 0774, Agent and Purchasers are the grantee of record of security interest in trademark rights identified in Schedule A hereto ("Trademarks") which was granted to Agent and Purchasers by Releasees.


Releasees have paid and/or performed in full their respective obligations to Agent and Purchasers and terminated all further obligations of Agent, on behalf of Purchasers, to extend credit to Releasees. Agent, on behalf of itself and Purchasers, desires by execution of this Release to grant to Releasees a termination and release of the security interest in and its rights, title, and interest in and to the Trademarks.

RELEASE

For good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of itself and Purchasers, hereby terminates and releases its security interest in the Trademarks, and Agent, on behalf of itself and Purchasers, further assigns and transfers to Releasees, and unto their respective successors and assigns, without recourse, all the right, title, interest, claim, or demand whatsoever the Agent, on behalf of itself and Purchasers, may have acquired in, through, or by said Trademark Security Agreement.
