**INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT**

This Intellectual Property Assignment Agreement (this "Assignment") is entered into and effective as of the 1st day of February, 2006 (the "Effective Date"), by and between MosquitoNix Holdings, LLC, a Delaware limited liability company, MosquitoNix, Inc., a Texas corporation, MNCO, Ltd., a Texas limited partnership, MNCO-GA, L.P., a Georgia limited partnership, MNCO-Tampa, Ltd., a Florida limited partnership, MosquitoNix Franchise Systems, Ltd., a Texas limited partnership, MNX Products, LP, a Texas limited partnership, and MNX Management, LLC, a Delaware limited liability company, with a business address of 14282 Gillis Road, Dallas, Texas 75244 (collectively, "Assignor"), and FEMO Holdings LP a Delaware limited partnership, with its principal business address at 14282 Gillis Road, Dallas, Texas 75244 ("Assignee").

WHEREAS, Assignor is the owner of certain Intellectual Property and Materials, as defined below; and

WHEREAS, Assignee wants to obtain, and Assignor desires to assign, all right, title and interest in and to the Intellectual Property and Materials.

NOW THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Definitions.

- a. "Business" shall mean the Assignor's business, that includes without limitation, selling, installing and maintaining insect misting systems and related products and services and franchising such operations.
- b. "Intellectual Property" shall mean Assignor's trade secrets, confidential materials, know-how, trademarks, trade dress, logos, domain names, copyrights, layouts, designs, licenses, architectural plans, source codes, patents, inventions, and any other intellectual property and intangible legal rights and interests pertaining to or planned to be used in connection with the Business (as well as any and all products and proceeds from the foregoing), irrespective of whether registered or unregistered, including but not limited to the items listed in Exhibit A.
- c. "Materials" shall mean (a) any and all written, preprinted, typed or visually or aurally recorded material of any kind featuring or pertaining to the Intellectual Property, including but not limited to signage, designs, architectural plans and blueprints, and advertising and promotional materials recorded in any medium; (b) any and all documents, notes, analyses, compilations, studies, summaries, work papers, concept drawings, investigations, search reports, websites, histories, computer files, works of authorship, ideas, procedures, processes, systems, methods, concepts, principles, discoveries, inventions, art, improvements, formulas, patterns, devices, compilations, information, lists, articles, codes, programs, techniques, apparatus, algorithms, designs, circuitry, hardware, firmware, software and data, pertaining to Assignor's Business or Intellectual

Property, irrespective of whether registered or registered, and (c) any portion, copy and extract of such Materials.

2. Assignment. Assignor does hereby, without reservation, irrevocably:

- a. sell, assign, transfer and convey to Assignee, its successors, assigns and legal representatives, all right, title and interest (past, present, future, and throughout the world) in and to the Intellectual Property, together with all corresponding goodwill and Materials; and
- b. acknowledge and agree that Assignor shall have no ownership, license, sublicense, right or immunity, either directly, indirectly, or by implication, estoppel or otherwise, to all or any part of the Intellectual Property or Materials or any corresponding goodwill.

3. Further Assurances.

- a. By no later than one week after the Effective Date of this Assignment, Assignor shall:
  - i. permanently cease all use, promotion, advertising and/or commercialization, of any nature and kind whatsoever, of Assignor's Business and the Intellectual Property;
  - ii. deliver to Assignee all Materials in its possession, power or control, as well as all files related to the Intellectual Property;
  - iii. take all necessary steps to effectuate the transfer to Assignee of the domain name registrations and all right, title and interest in and to the code and content in the corresponding website, as set forth in Exhibit A hereto; and
  - iv. perform such acts as Assignee lawfully may reasonably request to facilitate Assignee's right to obtain, protect, maintain, perfect, defend or enforce the right, title, and interest of any of the Intellectual Property or Materials granted hereunder.

4. Assignor's Representations and Warranties. Assignor represents and warrants that it has not executed, and will not execute, any agreement in conflict herewith.

5. Governing Law. This Assignment shall be deemed entered into in Texas and shall be governed by and construed and interpreted in accordance with the laws of the State of Texas that apply to contracts executed in and performed entirely within the State of Texas, without reference to any rules of conflict of laws.

IN WITNESS WHEREOF, the undersigned parties have executed this Assignment and caused the same to be duly delivered on their behalf as of the Effective Date, notwithstanding any later date set forth below.
