

The Collateral Congress intends to sell by private sale on or after November 28, 2005 is described as follows:

- (a) certain hunting oriented computer software games owned by Arush Publishing Corporation ("Arush") described and known as HUL 2 and HUL 3, including without limitation, any and all source code and object code, product development materials, documentation for the compilation and use of source code, maintenance and support materials, instruction and user manuals, prototypes, schematics, sketches, photographs, graphics, text, negatives, screen images, sounds, music, audiovisual features, rules of play, concepts, themes, and packaging, including without limitation, all improvements and/or modifications to any of the foregoing;
- (b) any and all intellectual property rights or similar rights associated with HUL 2 and HUL 3; including without limitation, all rights of copyright, patent, trade secret, trademark, service mark, titles, trade dress, "look and feel," artistic and moral rights, mask rights, character rights, sequel rights, publicity rights, and any and all other propriety rights of any kind whatsoever relating to HUL 2 and HUL 3, together with any and all applications, registrations, renewal and extension rights, and rights to sue for any past, present or future infringement;
- (c) any and all intellectual property rights or similar rights of Arush, including without limitation, all rights of copyright, patent, trade secret, trademark, service mark, titles, trade dress, "look and feel," artistic and moral rights, mask rights, character rights, sequel rights, publicity rights, and any and all other propriety rights of any kind whatsoever, together with any and all applications, registrations, renewal and extension rights, and rights to sue for any past, present or future infringement, in and to the business of Arush relating to the assets set forth on this Exhibit 1;

- (d) any and all rights in and to any and all consents, releases, permits, licenses, or other instruments of transfer or permission provided to Arush by any third party in connection with the HUL 2 or HUL 3;
- (e) any and all rights of Arush in and to the Arush Entertainment Development and Publishing Agreement by and between Arush and SCS Software dated as of October 20, 2004;
- (f) any and all rights of Arush, including but not limited to copyrights and rights to copyrights, in and to the soundtrack contained in that certain fourth in a series of hunting oriented computer software games described and known as HUL 4, both in the composition of the soundtrack and in the recording performed by David Sadowski, d/b/a Soundrama, as contained in HUL 4;
- (g) those domain names or URLs, including huntingunlimited2.com, huntingunlimited2.net and huntingunlimited3.com, used in Arush's business or relating to the assets set forth on this Exhibit 1 and any and all domain names, key words, metatags, or other similar assets or rights and rights related thereto; including but not limited to the right to transfer, exploit, modify, change or adapt in any manner any of the foregoing, reversionary and renewal rights in any of the foregoing, and rights to sue for and collect damages for any past, present or future infringements or other violations of any of the foregoing arising out of or related to the business of Arush;
- (h) all goodwill of Arush's business related to the assets set forth on this Exhibit 1;
- (i) United States Trademark, HUNTING UNLIMITED, Registration No. 2672973, and all related goodwill and any and all rights to transfer, exploit, modify, change or adapt in any manner the foregoing, reversionary and renewal rights in the foregoing, and rights to sue for and collect damages for any past, present or future infringements or other violations of rights in and to the foregoing. Any and all trademarks or service marks (whether registered or unregistered), related goodwill, trademark or service mark application(s), trade names, fictitious

business names, domain names, key words, metatags, trade dress, and all other terms, designs, or devices that function as an indication of source or origin utilized in connection with Arush's business and/or related to or contained in the assets set forth in this Exhibit 1; including but not limited to the right to transfer, exploit, modify, change or adapt in any manner any of the foregoing, reversionary and renewal rights in any of the foregoing, and rights to sue for and collect damages for any past, present or future infringements or other violations of any of the foregoing;

- (j) Any and all copyright or rights of copyright (whether registered or unregistered), copyright application(s), character rights, documentation, moral and artistic rights, publicity rights, the right to reproduce, distribute, publicly display, publicly perform, create derivative works of, transfer, exploit, modify, change or adapt in any manner any of the foregoing, reversionary and renewal rights in any of the foregoing, and rights to sue for and collect damages for any past, present or future infringements or other violations of any of the foregoing, included in or related to HUL 2, HUL 3, Arush's business or the assets set forth on this Exhibit 1; and
- (k) all intellectual property and proprietary rights, including without limitation, all rights of copyright; patent; trade secret, confidential information, and know-how; trademark and service mark (including without limitation, the domain names "huntingunlimited2.com," "huntingunlimited2.net" and "huntingunlimited3.com" in any form and with any associated designs or logos), any other designation of source or origin; trade dress; artistic and moral rights; mask rights; character rights; publicity rights; and any and all other proprietary rights of any kind whatsoever relating to the HUL 2, HUL 3, the assets set forth on this Exhibit 1 or the business of Arush, all associated goodwill, and together with any and all applications, registrations, renewal and extension rights, and rights to sue for any past, present, or future infringement relating to any of the foregoing.
