
ASSIGNMENT OF TRADEMARK APPLICATIONS

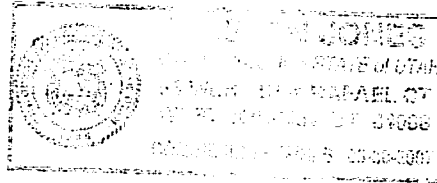
