ASSIGNMENT OF TRADEMARK APPLICATIONS



The undersigned hereby appoints Assignee to be the undersigned's attorney-in-fact with an irrevocable power to do all acts and things for and in the name of the undersigned in connection with the Property.



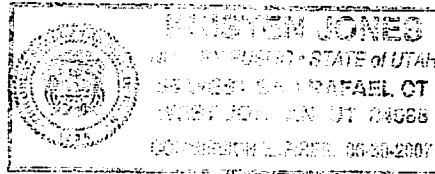
