TRADEMARK ASSIGNMENT AGREEMENT

This Agreement is entered into by and between

Saab Automobile AB, a company organized and existing under the laws of Sweden and having a principal place of business at 461 80 Trollhattan, Sweden ("Saab Auto"), and

Saab Aktiebolag, a company organized and existing under the laws of Sweden and having a principal place of business at 581 88 Linköping, Sweden ("Saab AB");


hereinafter referred to individually as a "Party" or collectively as the "Parties".

2. Saab Auto hereby accepts assignment of U.S. Trademark Reg. No. 1,035,072.
3. The Parties represent and warrant that they have the right and power to enter into this Agreement and grant the assignment herein contained.
4. The Parties agree to execute any documents, reasonably requested by the other Party, to effectuate the intent of this Agreement.


