

DECLARATION


I am a partner in the law firm Neal, Gerber & Eisenberg LLP and am outside trademark counsel to Intellitrans, LLC. On December 24, 2002, a trademark assignment between Joseph Transportation, Inc. as assignor and Intellitrans, LLC as assignee was improperly recorded at Reel 2639 and Frame 0645 against U.S. Registration Nos. 2274968, which, according to the records reflected by the U.S. Patent and Trademark Office's TARR system, is owned by Red Wing Shoe Company, Inc.

The chain of title for Reg. No. 2274968 should not have been altered as Joseph Transportation, Inc. was not the owner of the registration at issue. Thus, the record of ownership of the registration should never have changed with respect to the assignment recorded at Reel 2639 and Frame 0645. Thus, the assignment was recorded in error and should be removed.
