does hereby certify that:

1. Baskin-Robbins Eastern Corp. owns all of the outstanding shares of stock of Baskin-Robbins Inc., a California corporation, and of Baskin-Robbins Southwest Corp., a Delaware corporation.
2. On November 29, 1973, the Board of Directors of Baskin-Robbins Eastern Corp. adopted the following resolutions to merge Baskin-Robbins Inc. and Baskin-Robbins Southwest Corp. into Baskin-Robbins Eastern Corp.:

"RESOLVED, that Baskin-Robbins Inc., a California corporation, and Baskin-Robbins Southwest Corp., a Delaware corporation, each of which corporations is a wholly owned subsidiary of this corporation, be merged into this corporation.

RESOLVED, that all of the estate, property, rights, privileges, powers and franchises of each of said subsidiary corporations be vested in and held and enjoyed by this corporation as fully and entirely and without change or diminution as the same were before held and enjoyed by each of said subsidiary corporations, and that this corporation assume all of the obligations of each of said subsidiary corporations.

RESOLVED, that this corporation shall cause to be executed, filed and recorded the documents prescribed by the laws of the State of Delaware and by the laws of the State of California and shall cause to be performed all necessary acts within the State of Delaware and within the State of California in order to effect the foregoing merger.
