**PLAN OF CONVERSION**

**NMHG Oregon, Inc., an Oregon Corporation  
Into  
NMHG Oregon, LLC, an Oregon Limited Liability Company  
December 31, 2005**

1. The name and type of the business entity prior to conversion is NMHG Oregon, Inc., an Oregon corporation (the "Corporation").
2. The name and type of the business entity after conversion is NMHG Oregon, LLC, an Oregon limited liability company (the "LLC").
3. The Corporation shall be converted into the LLC (the "Conversion") effective as of December 31, 2005 with the Secretary of State of Oregon of Articles of Conversion. The Conversion shall occur in accordance with the applicable provisions of ORS Chapter 60 governing Oregon business corporations and ORS Chapter 63 governing Oregon limited liability companies.
4. The sole shareholder of the Corporation will be the sole member of the LLC and in the conversion the outstanding shares of common stock of the Corporation will be converted into a 100% membership interest in the LLC. The LLC will be member-managed by the sole member.
5. Effective upon the Conversion, the LLC will be governed by the Articles of Conversion filed with the Secretary of State of Oregon, including the provisions of Exhibit A to this Plan of Conversion, and the Operating Agreement of the LLC executed and delivered by the sole member of the LLC effective upon the Conversion. **ARTICLES OF ORGANIZATION OF  
NMHG OREGON, LLC**

**ARTICLE I**

The name of the limited liability company (the "Company") is NMHG Oregon, LLC.

**ARTICLE II**

The Company shall have perpetual existence.

**ARTICLE III**

The name of the registered agent is Corporation Service Company and the address of the registered office is 285 Liberty Street, N.E., Salem, OR 97301.
