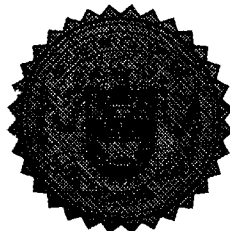




3. A copy of the Plan of Merger setting forth the terms and conditions of the merger is attached hereto as Exhibit A.
