NUNC PRO TUNC ASSIGNMENT OF UNITED STATES
TRADEMARK RIGHTS

WHEREAS, The Viking Corporation ("Assignor"), a corporation duly organized and existing under the laws of the State of Michigan, and having an office at 210 N. Industrial Park, Hastings, Michigan 49058, is the record owner of the trademark **GUARD-LOCK** including U.S. Trademark Reg. No. 1,489,011 for the mark **GUARD-LOCK** (collectively, "the Trademark"); and

WHEREAS, Brammall Inc., doing business as TydenBrammall ("Assignee") , a corporation duly organized and existing under the laws of the State of Indiana having an office located at 409 Hoosier Drive, P.O. Box 208, Angola, Indiana 46703; and

WHEREAS, on or about October 4, 2002, Assignor and Assignee were closely related companies, and Assignor did assign to Assignee all of its right title and interest in and to the Trademark, including the right to recover for all claims for damages for past infringements; and


WHEREAS, it having been discovered that the Trademark assignment to Assignee was not reduced to writing, the parties hereby desire memorializing the assignment in writing.

NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor, effective as of October 4, 2004, does hereby sell, convey, assign, transfer and deliver to Assignee, for its use and the use of its successors, assigns and legal representatives, all of Assignor's right, title and interest in and to the Trademark along with the goodwill of the Business symbolized by the Trademark, together with any and all renewal thereof for the full term or terms of all such rights, together with its right to sue and recover all claims for damages for past infringement, for its own use and for the use of its successors, assigns and legal representatives; and


FURTHER, Assignor represents, warrants and agrees that upon the reasonable request of Assignee and at Assignee's expense, Assignor shall execute and deliver any further instruments or documents and take all such further action, or cause any affiliate of Assignor to do the same, to perfect Assignee's right, title and interest in the Trademark assigned by this assignment; and




