Under Section 904 of the New York Business Corporation Law

We, the undersigned, being respectively the President and Secretary of Amarel Precision Instruments, Inc. and the President and Secretary of Optem International, Inc. certify that

1. The name of each constituent corporation is Amarel Precision Instruments, Inc ("Amarel"), a New York corporation, and Optem International, Inc. ("Optem"), a New York corporation. The name of the surviving corporation is Amarel Precision Instruments, Inc.
2. Amarel has authorized 3,200,000 Common Shares, par value \$.10, of which 1,077,473 are outstanding. Optem has authorized 200 shares of Common Stock, no par value, of which 100 shares are issued and outstanding. None of the shares is entitled to vote as a class. None of the shares is subject to change prior to the effective date of the merger.
3. The Certificate of Incorporation of the surviving corporation is hereby amended to change the name of the corporation to Avimo Precision Instruments, Inc. The amendment is effected by amending subsection 1 of the Restated Certificate of Incorporation to read in its entirety as follows:  
  
The name of the corporation is Avimo Precision Instruments, Inc.
4. The merger shall be effective as of September 30, 1999
5. The certificate of incorporation of Amarel was filed by the New York Secretary of State on October 16, 1980. The certificate of incorporation of Optem International, Inc. was filed by the New York Secretary of State on January 13, 1992
6. The merger was authorized at a meeting of the Board of Directors and by unanimous written consent of the shareholders of Amarel. The merger was authorized by unanimous written consent of the directors and the sole shareholder of Optem
