FIRST AMENDMENT TO TRADEMARK SECURITY AGREEMENT

THIS FIRST AMENDMENT TO TRADEMARK SECURITY AGREEMENT dated as of December 21, 2005 (this "Amendment") is among THE MAJESTIC STAR CASINO, LLC, an Indiana limited liability company (the "Company"); THE MAJESTIC STAR CASINO CAPITAL CORP., an Indiana corporation (together with the Company, the "Issuers"); each of the undersigned Subsidiaries of the Company (together with the Issuers, the "Debtors"); and THE BANK OF NEW YORK TRUST COMPANY, N.A. (together with any successor Trustee pursuant to the terms of the Indenture, the "Secured Party"), acting in the capacity of collateral agent for the benefit of the holders of the Notes of the Issuers issued under the Indenture.

RECITALS

WHEREAS, reference is made to that certain Indenture, dated as of October 7, 2003 (as it has been and may be amended, restated, supplemented or otherwise modified from time to time, the "Indenture"), by and among the Debtors and the Secured Party;

WHEREAS, in accordance with the Indenture, the Debtors and the Secured Party have entered into that certain Pledge and Security Agreement, dated as of October 7, 2003 (as it has been or may be amended, restated, supplemented or otherwise modified from time to time the "Pledge and Security Agreement");

WHEREAS, under the Pledge and Security Agreement, the Issuers, and each of the Debtors a signatory thereto, and the Secured Party entered into that certain Trademark Security Agreement dated October 7, 2003 (the "Trademark Security Agreement"); and

WHEREAS, the Issuers, the Debtors and the Secured Party have agreed to amend the Trademark Security Agreement as set forth herein.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, subject to the satisfaction of each of the conditions precedent set forth herein, the parties agree to amend the Trademark Security Agreement as follows:

1. DEFINITIONS. Capitalized terms used herein and not otherwise defined herein shall have the meanings ascribed to them in the Trademark Security Agreement, as amended hereby.
2. AMENDMENT TO TRADEMARK SECURITY AGREEMENT. The Trademark Security Agreement is hereby amended by amending and restating Schedule A to the Trademark Security Agreement in its entirety as set forth on Schedule 1 to this Amendment.
3. ENTIRE AMENDMENT; EFFECT OF AMENDMENT. This Amendment, and terms and provisions hereof, constitute the entire agreement among the parties pertaining to the subject matter hereof and supersedes any and all prior or contemporaneous amendments relating to the subject matter hereof. Except for the amendment to the Trademark Security Agreement

expressly set forth herein, the Trademark Security Agreement shall remain unchanged and in full force and effect.


