ASSIGNMENT OF TRADEMARK


Assignor agrees to execute and deliver at the request of the Assignee, all papers, instruments, and assignments, and to perform any other reasonable acts the Assignee may require in order to vest all Assignor's rights, title, and interest in and to said Mark and said Registration in the Assignee and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by the Assignee, to the extent such execution of any forms, statements or other documents required by any trademark office relating to the Mark or the Registration listed in Schedule A. Notwithstanding the foregoing, Assignee shall be exclusively responsible for any fees or payments to third parties arising from such efforts.

Assignor agrees and consents to the fact that Assignee, in its sole discretion, may apply for and register variations of the Mark, including but not limited to the standard character format of the Mark, in all such jurisdictions as Assignee in its sole discretion may determine as well as make any amendments to the existing Registration as may be required. Assignor further agrees not to oppose any such further applications, registrations and/or amendments and shall not bring any actions against Assignee under the Lanham Act or state common law related to Assignee's use and ownership related to the Mark and any applications, registrations or amendments related to the Mark.

Assignor hereby covenants that it has full right to convey the entire interest herein assigned and that it has not executed, and will not execute, any agreement in conflict herewith.


