ASSIGNMENT NUNC PRO TUNC

WHEREAS, SPX Holding Inc., a Connecticut corporation, formerly known as Edwards Systems Technology, Inc. ("Assignor"), owns the entire right, title, and interest in and to the following trademark and trademark application attached hereto as Schedule A (hereinafter "Trademark").

Assignor further assigns to Assignee, nunc pro tunc, all the rights to sue for past, present, and future infringements, and all rights corresponding thereto throughout the world for the Trademark.
