## **TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST**

This Termination and Release of Trademark Security Interest is entered into as of March \_\_, 2006 by and between BANK OF AMERICA, N.A. ("*Bank of America*") ("Collateral Agent"), as administrative agent under that certain Grant of Trademark Security Interest dated as of September 29, 2003 (the "Trademark Security Agreement") and LEVI STRAUSS & CO. ("Secured Party").

### **WITNESSETH:**

WHEREAS, Secured Party and Collateral Agent are parties to the Trademark Security Agreement;

WHEREAS pursuant to the Trademark Security Agreement (and other agreements referenced therein) and all IP Supplements (as defined in the Intellectual Property Security Agreement dated as of September 29, 2003) thereunder, Secured Party granted Collateral Agent a security interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement) including, without limitation, those certain trademarks and trademark applications set forth in Schedule A (collectively, the "Secured Trademarks"), which security interest was recorded in the United States Patent and Trademark Office; and

WHEREAS, Secured Party has satisfied its obligations under the Trademark Security Agreement (and other agreements referenced therein) and Collateral Agent now desires to terminate and release the entirety of its security interests, liens, encumbrances and all other rights in the Trademark Collateral and restore all right, title and interest in and to such Trademark Collateral to Secured Party.

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral, the receipt and adequacy of which are hereby acknowledged, the Collateral Agent and Secured Party hereby agree as follows:

1. The Collateral Agent hereby terminates and releases in its entirety its security interests, liens, encumbrances and all other rights in the Trademark Collateral and hereby releases, discharges, quitclaims, relinquishes unto, and assigns to the Secured Party any and all of its right, title and interest, if any, in and to the Trademark Collateral, including, without limitation:

(a) all rights, title, and interest (including rights acquired pursuant to a license or otherwise) in and to all trademarks, service marks, designs, logos, indicia, tradenames, trade dress, corporate names, company names, business names, fictitious business names, trade styles and/or other source and/or business identifiers and applications pertaining thereto, owned by Secured Party, or hereafter adopted and used, in its business, including the Scheduled Trademarks (collectively, the "Trademarks"), all registrations that have been or may hereafter be issued or applied for thereon in the United States and any state thereof and in foreign countries, all common law and other rights in and to the foregoing in the United States and any state thereof and in foreign countries, and all goodwill of Secured Party's business symbolized by the

Trademarks and associated therewith, it being understood that the rights and interests included in the Trademark Collateral include, without limitation, all rights and interests pursuant to licensing or other contracts in favor of Secured Party pertaining to Trademarks presently or in the future owned or used by third parties but, in the case of third parties which are not Affiliates (as defined in the Credit Agreement dated as of September 29, 2003 among Secured Party, several financial institutions from time to time party thereto and Collateral Agent) of Secured Party, only to the extent permitted by such licensing or contracts and, if not so permitted, only with the consent of such third parties; and

(b) all proceeds (as defined in the Trademark Security Agreement), products, rents, profits and royalties of or from any and all of the Trademark Collateral and, to the extent not otherwise included, all payments under insurance, or any indemnity, warranty or guaranty, payable by reason of loss or damage to or otherwise with respect to any of the Trademark Collateral.

2. The Collateral Agent hereby authorizes and requests the Commissioner of Patents and Trademarks to record this release.

3. This Termination and Release of Trademark Security Interest may be executed in counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

4. This Termination and Release of Trademark Security Interest shall be governed by, and construed in accordance with, the laws of the State of New York.
