1. The name of the Corporation is Avimo Precision Instruments, Inc. The Corporation was formed under the name Amarel Precision Instruments, Inc.
2. The certificate of incorporation of the Corporation was filed by the Department of State of the State of New York on October 16, 1980.
3. The Certificate of Incorporation is hereby amended to change the name of the Corporation to Thales Optem Inc. The amendment is effected by amending Subsection 1 of the Certificate of Incorporation to read in its entirety as follows:
