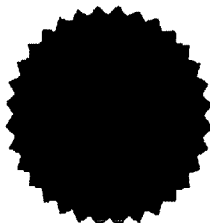

The resolution setting forth the proposed amendment is as follows:

"The name of the Corporation is EnerSys Energy Products Inc."
