ASSIGNMENT OF U.S. TRADEMARK

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Taro does hereby sell, assign, transfer and set over to FSC all of Taro's right, title and interest in, to and under the Mark, together with the goodwill of the business symbolized by the Mark, together with all rights and privileges granted and secured thereby, including the right to sue and recover for any past infringement, the rights to be held and enjoyed by FSC, for its own use and benefit and for the use and benefit of its successors, assigns or other legal representatives as fully and entirely as the same would have been held and enjoyed by Taro if this Assignment and sale had not been made.
