IN WITNESS WHEREOF, the parties hereto have caused this Assignment to be executed and effective as of the 15th day of March, 2006.



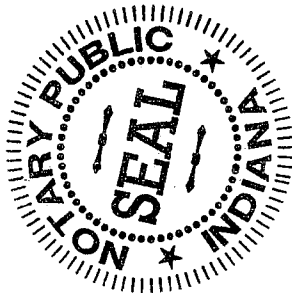
