

CERTIFICATE OF GENERAL PARTNER AS TO OWNERSHIP OF MARKS AND REGISTRATIONS AND CONVERSION OF THE PARTNERSHIP TO AN LLC WITH DECLARATION

The undersigned, a duly authorized officer of Rofan Services Inc. ("Rofan"), a Delaware corporation that is a subsidiary of The Dow Chemical Company and a partner in the general partnership known as DowElanco (the "Partnership"), which Partnership was formerly comprised of Rofan and Epcoc Inc. ("Epcoc"), an Indiana corporation, and governed by the laws of the State of Indiana, hereby certifies and declares that:

1. The Partnership is the record owner of certain trademarks which are now registered with the U.S. Patent and Trademark Office ("USPTO") or are the subject of a pending registration application with the USPTO, all of which are identified on *Schedule "A"* attached to (and immediately preceding) this Certificate and made a part hereof.
2. Under the terms of an agreement between Rofan and Epcoc in effect as of June 30, 1997, governing the Partnership and the relationship of the partners in the Partnership (the "Partnership Agreement"), and in accordance with the applicable laws of the States of Indiana and Delaware, the partners of the Partnership were empowered and authorized to amend, and did on such date amend, the Partnership Agreement to provide, effective from and after July 1, 1997:
 - (a) for the admission of another partner to the Partnership (namely, Centen AG Inc., a Delaware corporation that is also a subsidiary of The Dow Chemical Company) and the concurrent withdrawal of Epcoc as a partner in the Partnership; and
 - (b) that the laws of the State of Delaware (rather than those of the State of Indiana) shall thereafter apply to and govern the Partnership and the relationship of the partners therein;

which actions were all implemented without termination or dissolution of the Partnership or otherwise causing the legal existence of the Partnership to cease.


3. On July 1, 1997, the Partnership filed with the Secretary of State of Delaware a Certificate of Conversion by which the Partnership, effective that date and in accordance with applicable Delaware law, converted from a Delaware general partnership to a Delaware limited liability company, with an attendant name change to "DowElanco LLC" (the "Conversion"). Attached to (and immediately following) this Certificate as an *Exhibit* hereto is a copy of the aforesaid Certificate of Conversion as filed with the Delaware Secretary of State, certified by the Office of the Secretary of State as a true and correct copy thereof.
4. Pursuant to the Conversion effective July 1, 1997, DowElanco LLC, as the successor of the Partnership by operation of Delaware law, became the owner of all right, title and interest of the Partnership in and to those trademarks and the registrations and applications therefor now of record with the USPTO; and DowElanco LLC is entitled to have its ownership of all such trademarks, registrations and applications duly recorded with the USPTO and its Assignment Division.

The undersigned further declares that the statements made herein of his/her own knowledge are true and all statements on information and belief are believed to be true; that these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code and that such willful and false statements may jeopardize the validity of this document or any registration resulting therefrom.


