The name of the corporation is Masco Services Group Corp.


SECOND: That the aforesaid amendment shall be effective December 31, 2003 at 11:59 p.m. Eastern Standard Time.

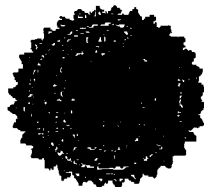
