**EXTRACTO**

Iván Torrealba Acevedo, Notario Público de Santiago, Huérfanos N°979, oficina 501, certifico que el 29 de diciembre 1998, fue reducida, ante mí, a escritura pública el Acta de la Junta Extraordinaria de Accionistas de "VIÑA GRACIA S.A.", con extracto inscrito a fojas 23.584 N°11.761 del Registro de Comercio de Santiago de 1990, celebrada en presencia mía, el 29 de diciembre de 1998. Se modificaron los estatutos sociales sustituyendo el actual nombre social por "VIÑEDOS Y BODEGAS CÓRPORA S.A.", estableciendo "Córpora Wineries & Vineyards" como expresión publicitaria, reemplazando en el domicilio social la palabra "ciudad" por el vocablo "comuna". Además, se sistematizó y refundió el actual artículo primero de los estatutos sociales, siendo el siguiente su texto: "Se constituye una sociedad anónima cerrada con el nombre de 'Viñedos y Bodegas Córpora S.A.'. Dicha denominación no obsta al uso de la expresión 'Córpora Wineries & Vineyards' para fines publicitarios o de propaganda. Su domicilio será la comuna de Santiago, Chile, pudiendo establecer agencias o sucursales en otros puntos del país o del extranjero". Santiago, 29 de diciembre de 1998.



**ABSTRACT**

Iván Torrealba Acevedo, Santiago Notary Public, Huérfanos N°979, suite 501, certifies that on December 29, 1998, before me, were registered as a public deed the Proceedings of the Extraordinary Meeting of the Shareholders of **"VIÑA GRACIA S.A."**, whose abstract is recorded in page 23,584 N° 11,761 of the Santiago Commerce Register (*Registro de Comercio de Santiago*) kept for the year 1990, held in my presence on December 28, 1998. The articles of incorporation were amended replacing the current company legal name with **"VIÑEDOS Y BODEGAS CÓRPORA S.A."**, establishing **"Córpora Wineries & Vineyards"** as an advertising expression, replacing in the company domicile the word "city" with the term "municipality". In addition, the existing first article in the articles of incorporation was made systematic and rewritten, its text being the following: "A closely held corporation is hereby incorporated with the name of 'Viñedos y Bodegas Córpora S.A.'. Said denomination does not prevent the use of the expression 'Córpora Wineries & Vineyards' for publicity or advertising. Its domicile will be the municipality of Santiago, with the authority to establish agencies or branch offices in other locations within the country or abroad". Santiago, December 29, 1998
