CONFIRMATORY TRADEMARK ASSIGNMENT

WHEREAS, BendyCo Incorporated, a California Corporation, on March 11, 2005, entered into a PURCHASE AGREEMENT with RectorSeal Corporation, a Delaware Corporation, having offices at 2601 Spenwick Drive, Houston, Texas 77055;

WHEREAS, under the PURCHASE AGREEMENT, all rights in the trademark WIRE SNAGGER (the "Mark") and United States Trademark Application No. 78/477,063, now Registration No. 3,020,362 registered on November 29, 2005 for the Mark, which BendyCo Incorporated used as a trademark, service mark and/or trade name in interstate commerce, were transferred to RectorSeal Corporation ("Assignee") by BendyCo Incorporated ("Assignor") along with the goodwill of the business connected with the Mark for good and valuable consideration; and

WHEREAS, Assignor and Assignee wish to confirm such assignment and transfer, including for recordation purposes, and whereas Assignor desires to assign and quitclaim any and all remaining rights in and to the Mark with the associated goodwill to Assignee;


NOW, THEREFORE, in reliance on the above and for the consideration stated in the PURCHASE AGREEMENT and other good and valuable consideration, the receipt of which is hereby acknowledged, Assignor has sold, assigned, transferred and quitclaimed and by these presents does hereby sell, assign, transfer and quitclaim unto the Assignee, its successors or assigns, all its right, title and interest to the Mark throughout the world, if any, in and to the Mark, trademark applications and registrations, including U.S. Registration No. 3,020,362 and all other foreign and domestic applications and registrations, for the mark WIRE SNAGGER, and in and to any renewals and extensions that may be granted thereon, together with the goodwill of the business connected therewith and any right to recover for past infringement thereof and other past injury thereto.

We, BendyCo Incorporated, do further covenant and agree that we will, at any time upon request, communicate to RectorSeal Corporation, its successors, assigns or other legal representatives, such facts relating to the Mark, the trademark registration therefore and the file history thereof as may be known to us, and testify as to the same in any proceeding or litigation when requested so to do, without further compensation but at the expense of RectorSeal Corporation, its successors or other legal representatives.

And we, BendyCo Incorporated, hereby warrant and represent that we have the full right to convey the entire interest herein assigned, and that we have not executed and will not execute any agreement in conflict herewith.
