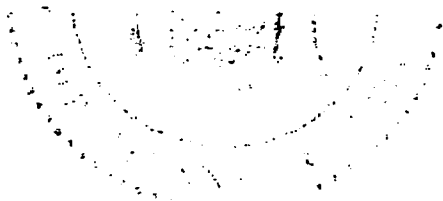

**CERTIFICATE OF INCORPORATION**

**CROSS COUNTRY PAPER PRODUCTS CORP.**

[Under Section 807 of the Business Corporation Law]

1. The name of the corporation is **CROSS COUNTRY PAPER PRODUCTS CORP.** (the "Corporation"). The name of the corporation when it was originally formed was "ADC MERGING CORP."

2. The Certificate of Incorporation of the Corporation was filed by the Department of State on January 24, 1990 and a Certificate of Amendment of the Certificate of Incorporation was filed with the Department of State on May 22, 1996 changing the name of the Corporation to "CROSS COUNTRY PAPER PRODUCTS CORP."

3. The Certificate of Incorporation is amended as follows:

A. Deleting in its entirety Article **FIRST** and replacing the same with a new Article **FIRST** to reflect the change in the name of the Corporation to **CROSSTEX INTERNATIONAL, INC.**

B. Adding a provision permitting the shareholders of the Corporation to act by written consent signed by the holders of outstanding shares having not less than the minimum number of votes that would be necessary to authorize or take such action at a meeting at which all shares entitled to vote thereon were present and voted.

C. Changing the service of process address from Cross Country Paper Products, 10 Ranick Road, Hauppauge, New York 11788 to Ruskin, Moscou, Evans & Faltischek, P.C. 170 Old Country Road, Mineola, New York 11501 Attn: Irvin Brum, Esq.

4. The amendments to the Certificate of Incorporation of the Corporation set forth in Sections 3A and B above were authorized in accordance with Section 803(a) of the Business Corporation Law of the State of New York (the "BCL"), by unanimous written consent of the Board of Directors pursuant to Section 708(b) of the BCL, and by majority vote at a meeting of the holders of all outstanding shares entitled to vote thereon pursuant to Section 614(b) of the BCL. The change in the address for service of process was authorized in accordance with Section 803(b) of the BCL, by unanimous written consent of the Board of Directors pursuant to Section 708(b) of the BCL.

5. The text of the Certificate of Incorporation is hereby amended and restated in its entirety as follows:

**FIRST:** The name of the corporation is CROSSTEX INTERNATIONAL, INC.

**SECOND:** The nature of the business and the purpose to be conducted and promoted by the Corporation is to engage in any lawful act or activity for which corporations may be organized under the BCL and it is not formed to engage in any act or activity requiring the consent or approval of any state official, department, board, agency or other body without such consent or approval first being obtained.

**THIRD:** The office of the Corporation is to be located in the County of Suffolk, State of New York.

**FOURTH:** The aggregate number of shares which the Corporation shall have authority to issue is Five Hundred Thousand (500,000) shares, all of which are to be shares of one class, designated as Common Stock, \$.01 par value.

**FIFTH:** The Secretary of State is designated as the agent of the Corporation upon whom process against the Corporation may be served. The post office address within the State of New York to which the Secretary of State shall mail a copy of any process against the Corporation served upon him is:

**SIXTH:** The duration of the Corporation is to be perpetual.

**SEVENTH:** No holder of any of the shares of any class of the Corporation shall be entitled as of right to subscribe for, purchase, or otherwise acquire any shares of any class of the Corporation which the Corporation proposes to issue or any rights or options which the Corporation proposes to grant for the purchase of shares of any class of the Corporation or for the purchase of shares, bonds, securities, or obligations of the Corporation which are convertible into or exchangeable for, or which carry any rights to subscribe for, purchase or otherwise acquire shares of any class of the Corporation, and any and all of such shares, bonds, securities or obligations of the Corporation, whether now or hereafter authorized or created, may be issued, or may be reissued or transferred if the same have been reacquired and have treasury status, and any and all of such rights and options may be granted by the Board of Directors to such persons, firms, corporations and associations, for such lawful consideration and on such terms as the Board of Directors in its discretion may determine, without first offering the same, or any thereof, to any said holder. Without limiting the generality of the foregoing stated denial of any and all preemptive rights, no holder of shares of any class of the Corporation shall have preemptive rights in respect of the matters, proceedings or transactions specified in subparagraphs (1) to (6), inclusive, of paragraph (e) of Section 622 of the BCL.

**EIGHTH:** The Corporation shall, to the fullest extent permitted by Article 7 of the BCL, as the same may be amended and supplemented, indemnify any and all persons whom it shall have power to indemnify under said Article from and against any and all of the expenses, liabilities, or other matters referred to in or covered by said Article, and the indemnification provided for herein shall not be deemed exclusive of any other rights to which any person may be entitled under any By-Law, resolution of shareholders, resolution of directors, agreement, or otherwise, as permitted by said Article, as to action in any capacity in which he served at the request of the Corporation.

**NINTH:** The personal liability of the directors of the Corporation is hereby eliminated to the fullest extent permitted by the provisions of paragraph (b) of Section 402 of the BCL, as the same may be amended and supplemented.

**TENTH:** Whenever the shareholders of the Corporation are required or permitted to take any action by vote, such action may be taken without a meeting on written consent, setting forth the action so taken, signed by the holders of outstanding shares having not less than the minimum number of votes that would be necessary to authorize or take such action at a meeting at which all shares entitled to vote thereon were present and voted.
