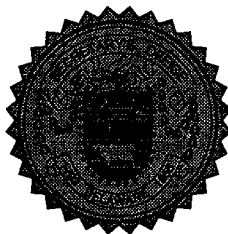

DOES HEREBY CERTIFY:

FIRST: That the Board of Directors of said corporation by unanimous written consent adopted on March 10, 2006, adopted a resolution proposing and declaring advisable the following amendment to the Certificate of Incorporation of said corporation:

RESOLVED, that the Certificate of Incorporation of EXL ACQUISITION CORP. be amended by changing the Article I thereof so that, as amended, said Article I shall be read as follows:

“ARTICLE I. The name of the corporation is: ENVIRONMENTAL EXPRESS, INC.”
