**QUITCLAIM DEED**

**THIS QUITCLAIM DEED** is made as of March 21, 2006 by Warren J. Martin Jr. (the "Assignee"), as Assignee for the Benefit of Creditors of Fleer/SkyBox International L.P. ("Fleer/SkyBox") in favor of Concord Confections Inc. ("Concord").

**RECITALS:**

**WHEREAS**, the Assignee was designated as the Assignee for the Benefit of Creditors of Fleer/Skybox pursuant to a Deed of Assignment recorded and filed on June 10, 2005.

**WHEREAS**, as Assignee for Fleer/SkyBox, the Seller has been charged with liquidating the assets of Fleer/SkyBox for the benefit of Fleer/SkyBox creditors.

**WHEREAS**, in connection liquidating Fleer/SkyBox assets, the Assignee entered into an Asset Purchase Agreement dated as of June, 2005 (the "APA") with FSB Acquisition Company, LLC ("FSB") for the sale and purchase of, *inter alia*, certain Fleer/SkyBox intellectual property as more fully described in the APA.

**WHEREAS**, Fleer/SkyBox, with offices formerly at Executive Plaza, 1120 Route 73 South, Mount Laurel, New Jersey 08054, is the registered proprietor of the following United States Trademark Registration (the "PUD Trademark"):


**WHEREAS**, FSB claims no right, title or interest in the PUD Trademark.

**WHEREAS**, the Assignee desires to transfer whatever right, title or interest the Fleer/SkyBox estate holds in the PUD Trademark to Concord.

**NOW, THEREFORE**, in consideration of the foregoing, and of other good and valuable consideration, the receipt and sufficiency of which are acknowledged, the Assignee agrees as follows:

- 1. Transfer of Property.** On behalf of the Fleer/SkyBox estate, the Assignee hereby assigns, conveys, transfers, and grants to Concord all of his right, title and interest in and to the PUD Trademark and the registration therefore, together with the goodwill of the business symbolized by the PUD Trademark and the registration therefore and including all rights to sue and recover for past infringement of the PUD Trademark and the registration therefore.
