**TERMINATION AND RELEASE OF SECURITY INTEREST IN CERTAIN
PATENTS AND TRADEMARKS** ("Release"), dated as of February 13th, 2004 by and between Marathon Technologies Corporation (the "Maker"), a Delaware corporation with an address at 1300 Mass Avenue, Boxborough, Massachusetts, in favor of Northern Technology Partners II LLC (the "Holder") with an address at P.O. Box 808, Shelburne, Vermont.

WHEREAS, pursuant to the terms of (i) the Secured Promissory Note dated as of July 31, 2002 by and between the Maker and the Holder and as filed with the Assignment Division at the United State Patent and Trademark Office on July 31, 2002 (at reel/frame nos. 002632/0561), and (ii) the Secured Promissory Note dated as of July 31, 2002 by and between the Maker and the Holder and as filed with the Assignment Division at the United State Patent and Trademark Office on December 13, 2002 (at reel/frame nos. 013552/0758), the Maker granted to the Holder a security interest in and lien on, among other collateral, all of its patents and trademarks, including, without limitation, the patents and trademarks identified on Schedule A and Schedule B attached hereto, including all right, title and interest of the Maker in said patents and trademarks, including all goodwill associated with said trademarks;

WHEREAS, the Holder wishes to release the security interest in and lien on, all of Maker's patents and trademarks, including, without limitation, the patents and trademarks identified on Schedule A and Schedule B attached hereto; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Holder and the Maker hereby agree as follows:

1. **Release and Assignment.** The Holder hereby terminates and releases its security interest in and first priority lien on all the Maker's patents, including, without limitation the patents identified on Schedule A attached hereto, effective as of the date set forth above.

2. **Release and Assignment.** The Holder hereby terminates and releases its security interest in and first priority lien on all the Maker's trademarks, including, without limitation the trademarks identified on Schedule B attached hereto, effective as of the date set forth above.

3. **Acknowledgement and Acceptance.** The Maker hereby acknowledges and accepts the forgoing release by the Holder.

4. **Counterparts.** This Release may be executed in any number of counterparts, which shall together constitute on and the same agreement.


