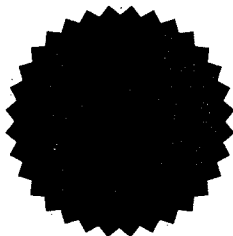

EFTC Operating Corporation, a Colorado corporation ("EFTC-Colorado") and EFTC Operating Corp., a Delaware corporation ("EFTC-Delaware"), each do hereby certify to the following facts relating to the merger of EFTC-Colorado with and into EFTC-Delaware (the "Merger").

FIRST: The names and states of incorporation of the constituent corporations to the Merger are as follows:

EFTC Operating Corp.	Delaware

SECOND: An Agreement and Plan of Merger (the "Merger Agreement") by and between EFTC-Colorado and EFTC-Delaware has been approved, adopted, certified, executed, and acknowledged by each constituent corporation, in accordance with the provisions of Section 252(c)(2) of the General Corporation Law of the state of Delaware.

THIRD: The name of the corporation surviving the Merger is EFTC Operating Corp., a Delaware corporation, and it is to be governed by the laws of the state of Delaware.

FOURTH: The Certificate of Incorporation of EFTC-Delaware as in effect immediately prior to the effective time of the Merger shall be the Certificate of Incorporation of the surviving corporation.

FIFTH: An executed copy of the Merger Agreement is on file at the office of EFTC-Delaware at 2501 West Grandview, Phoenix, Arizona 85023.

SIXTH: A copy of the Merger Agreement will be furnished by EFTC-Delaware upon request and without cost, to any stockholder of any constituent corporation.

SEVENTH: The authorized capital stock of EFTC-Colorado is 100,000 shares of common stock, \$.01 par value, and 5,000 shares of preferred stock, \$.01 par value.
