ASSIGNMENT OF PATENTS & TRADEMARKS

(Release of Security Interests Therein)

WACHOVIA BANK, NATIONAL ASSOCIATION, formerly known as "First Union National Bank" (First Union National Bank being the successor by merger to CoreStates Bank, N.A., and CoreStates Bank, N.A. being the successor by merger to **MERIDIAN BANK**, the original secured party and assignee with respect to the matters set forth herein) ("ASSIGNOR") with offices at 35 North Sixth Street, P.O. Box 1102, Reading, Pennsylvania 19603 certifies and agrees as follows:


1. Meridian Bank, as predecessor of ASSIGNOR, obtained security interests in and assignments of the United States Patents and patent applications described on SCHEDULE A ("PATENTS") and the Registered Trademarks and Applications for Trademark Registration (together with all associated goodwill) described on Schedule B ("TRADEMARKS") now owned by **MAGNATECH INTERNATIONAL, L.P.**, a Pennsylvania limited partnership ("ASSIGNEE"), which security interests and assignments were heretofore granted by ASSIGNEE, or its predecessor, David Thun, Inc., a Pennsylvania corporation, as appropriate, as collateral security for the repayment of certain indebtedness to Meridian Bank; and
2. ASSIGNEE has repaid all indebtedness owed to ASSIGNOR and its predecessors in full and has otherwise satisfied the conditions of the documents and instruments pursuant to which the aforementioned security interests and assignments were granted and is entitled to the cancellation of ASSIGNOR's security interest in and to the PATENTS and TRADEMARKS and the assignment of ASSIGNOR's interest therein to ASSIGNEE; and
3. ASSIGNOR has not previously assigned or otherwise transferred its interest in the PATENTS or TRADEMARKS, or any of them, to any other person or entity;

NOW, THEREFORE, in consideration of the payment of Ten (US\$10.00) U.S. Dollars, and other good and valuable consideration, the receipt and sufficiency of which are acknowledged by the ASSIGNOR, ASSIGNOR, intending to be legally bound, by these presents, does hereby irrevocably and unconditionally (1) acknowledge and agree that its lien on, and security interest in, the PATENTS and the TRADEMARKS is terminated and (2) sell, assign, transfer and dispose of its entire right, title and interest in and to the PATENTS and TRADEMARKS, and any of them, to ASSIGNEE to be held and enjoyed by said ASSIGNEE for its own use, behoof and benefit, and for the behoof and benefit of ASSIGNEE's legal representatives and assigns, free and clear of any claim or interest of ASSIGNOR, or any person or entity claiming by or through ASSIGNOR.

FURTHER, ASSIGNOR authorizes ASSIGNEE to record this Assignment and shall execute and deliver to ASSIGNEE, such other documents as ASSIGNEE, its legal representatives or assignees may reasonably require to effect and/or confirm the cancellation of ASSIGNOR's interest in and to the PATENTS and TRADEMARKS, and any of them.

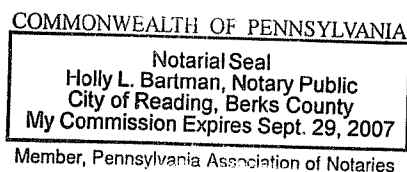
