Pursuant to Section 251 of the Delaware General Corporation Law, the undersigned surviving corporation submits the following Certificate of Merger for filing with the Secretary of State of the State of Delaware and certifies to the following information relating to the merger (the "Merger") of Richmond County Financial Corp. with and into New York Community Bancorp, Inc. ("New York Community"):

1. The name and state of incorporation of each of the domestic corporations (each a "Constituent Corporation" and collectively the "Constituent Corporations") which are to merge are:

3. New York Community shall be the surviving corporation in the Merger (the "Surviving Corporation"). The name of the Surviving Corporation is New York Community Bancorp, Inc.

4. The Certificate of Incorporation of New York Community shall be the certificate of incorporation of the Surviving Corporation.
